



Dear Water Customer:

The City of Geneva is proud of the water that we deliver to you every day. In order to protect our water distribution system, the City needs your assistance in submitting a Cross Connection Control Survey that can be found **on the back of this letter or online**.

The Illinois Environmental Protection Agency (IEPA) requires all water systems in the state to have an effective cross connection control program. Cross connections within the public water supply can be a serious concern since they can allow pollutants to enter the public water system through what is called backflow.

Backflow occurs when a drop in water pressure causes your water to flow in the opposite direction, potentially resulting in contamination in your drinking water.

Given IEPA regulations and the dangers that exist from unprotected cross connections, the survey is a critical component to make sure the proper backflow devices are in place for irrigation systems, boilers, and fire protection systems to name a few. Your cooperation helps the City follow state standards and maintain safe drinking water for the entire community.
